1.1 ionizing radiations from or contamination by radioactivity from any nuclear fuel or from any nuclear waste or from the combustion of nuclear fuel

1.2 the radioactive, toxic, explosive or other hazardous or contaminating properties of any nuclear installation, reactor or other nuclear assembly or nuclear component thereof

1.3 any weapon or device employing atomic or nuclear fission and/or fusion or other like reaction or radioactive force or matter

1.4 the radioactive, toxic, explosive or other hazardous or contaminating properties of any radioactive matter. - 1.6 The departure of the Assured's and/or project management personnel from any country, project or site in circumstances where:

ELECTRONIC DATE RECOGNITION ENDORSEMENT - C (XLEDRC)

This endorsement shall prevail notwithstanding any provision whether written typed or printed in this contract inconsistent herewith.

- 1. This contract does not cover loss, damage, liability or expense arising from or in any way connected, whether directly or indirectly, with;
 - a) the actual or anticipated failure or inability of any computer or electronic device or component or system or software or embedded programming, whether or not belonging to or in the possession of the direct Assured;
 - i) correctly and unambiguously to assign any date to the correct day, week, year or century, ii) correctly to recognise sequence or compute any date which is or is intended to be beyond 31 December 1998, iii) to continue to operate as it would have done had its current date, the true date and any other date relevant to any function being carried out by it been prior to 1 January 1999;
 - b) the use of any arbitrary, ambiguous or incompletely defined date or date-like code in any data, software or embedded programming;
 - c) any measures taken whether preventative, remedial or otherwise with the intention of averting or minimising any of the above.
- 2. Notwithstanding 1.a) and 1.b.) above, this contract shall be extended to include;
 - a) loss or damage arising from physical loss of or physical damage to tangible property;
 - b) liability for actual or alleged bodily injury;
 - c) liability for physical loss of or physical damage to tangible property owned by another person and resulting loss of use of such physically lost or physically damaged property; provided that such loss, damage or liability above is within the terms conditions and exclusions of the original policy(ies) or contract(s).
- 3. For the purposes of 2. above, tangible property shall not include;
 - a) any data or embedded programming however stored or conveyed;
 - b) any computer or electronic device or component or system or software, other than where such property forms part of an insured cargo or ship's machinery, which is in any way connected whether directly or indirectly with loss or damage claimed or from which such loss or damage arises.
- 4. This endorsement shall not include loss, damage, liability or expense arising from any contract solely designed to cover losses arising from any matter referred to in 1. above.
- 5. In calculating the net loss under this contract the reassured shall not treat any matter referred to in this endorsement as a basis for aggregation or in itself as an event or cause for the purpose of aggregation.

INFORMATION TECHNOLOGY HAZARDS CLAUSE XL 2002/03

Losses otherwise recoverable under this Contract arising, directly or indirectly, out of:

- loss of, or damage to, or

- a reduction or alteration in the functionality or operation of a computer system, hardware, programme, software, data, information repository, microchip, integrated circuit or similar device in or connected with computer equipment or non-computer equipment, whether the property of the policyholder of the reinsured or not, shall not be aggregated.

If such losses are caused directly by one or more of the following physical perils, namely theft of equipment, collision, sinking, grounding or stranding of carrying vessel, overturning or derailment of land conveyance, jettison or washing overboard, fire, lightning, explosion, aircraft or vehicle impact, falling objects, windstorm, hail, tornado, cyclone, hurricane, earthquake, volcano, tsunami, flood, freeze or weight of snow, then this clause shall not prevent the aggregation of losses if otherwise permitted under the terms of this Contract if they are caused by any such peril(s).

GENERAL CONDITIONS

OPEN DECLARATION CLAUSE [Applicable for Marine Open Declaration Policy]

It is a condition of this policy that the Assured is bound to declare each and every shipment or sending or risk without exception falling within the terms of this policy whether arrived or not, the underwriters/insurers being bound to accept same up to but not exceeding the limit specified herein. Monthly declaration of all shipments has to be submitted as per basis of valuation of the policy by the insured to insurer in agreed format by 15th of succeeding month providing all transit particulars per consignment/dispatch. In addition to the above, the Assured has to ensure adequacy of sum insured at all times &/or adequate sum insured should be available for the relevant dispatch as on date of AWB/BL/RR/CN/LR as applicable.

PREMIUM ADJUSTMENT CLAUSE [Applicable for Marine Open Declaration Policy]

It is further agreed that the policy would be adjusted (downward only in view of premium payment regulation) on the basis of the actual transit value declared as per the basis of valuation mentioned in the policy (i.e. if the basis of valuation is Invoice plus 10%, then Assured will declare total sales on 110% basis). In the event of cancellation of policy by either party as per the cancellation clause, pro-rata refund of premium will be made. However, in the event of unutilized balance sum insured remained after expiry of the policy due to declaration, a minimum retention of 70% (or as specified in the Schedule) of the deposit premium shall be made under the policy. In case of assured claiming a refund for more than 25% of the deposit premium after expiry of the policy for unutilized balance sum insured, the insurer shall reserve the right to request insured to produce a certificate from an independent chartered accountant or audit firm certifying the actual insurable value of goods during the policy period.

OVER DECLARATION CLAUSE [Applicable for Marine Open Declaration Policy]

No liability to attach in respect of declarations in excess of amount insured by this open policy or subsequent endorsements.

SALES TURNOVER CLAUSE [Applicable for Policy based on Sales Turnover]

This policy is issued on Sales Turnover basis where the premium has been collected or the rate is chargeable only upon the Estimated Annual Sales Turnover of the Assured. It is hereby declared and agreed that besides Sales, the inputs – raw material and other items which go into the making of the output - either locally procured or imported, inter-depot movement, return transit, as enumerated in the policy, are also covered under the policy. However, purchase of capital goods, containers, movement of capital goods can be covered with separate declaration and at payment of additional premium under the policy. Premium would be paid to the Insurer on agreed intervals.

DECLARATION CLAUSE [Applicable for Policy based on Sales Turnover]

It is agreed that the Assured will declare their Quarterly Sales figures as per basis of valuation mentioned in policy (i.e. if the basis of valuation is Invoice plus 10%, then Assured will declare total sales on 110% basis) and Capital Goods/Duty Sum Insured (if opted)

to be declared separately on actual basis. In addition to the above, the Assured has to ensure adequacy of Sum Insured at all times in view of premium payment regulation.

PREMIUM ADJUSTMENT CLAUSE [Applicable for Policy based on Sales Turnover]

It is further agreed that the final adjustment of the premium would be done after the expiry of the policy and the policy would be adjusted (downward only in view of premium payment regulation – Section 64 VB of Insurance Act) on the basis of the actual final Sales Turnover (as per basis of valuation mentioned in the policy) achieved by the Assured subject to retention of 70% (or as specified in the Schedule) minimum deposit premium. For claiming refund, actual sales turnover achieved during the policy period, as certified by insured's Auditors or published in their audited Annual Report should be submitted.

OVER DECLARATION CLAUSE [Applicable for Policy based on Sales Turnover]

No liability to attach in respect of declarations in excess of amount insured by this open policy or subsequent endorsements.

LIMITATION OF LIABILITY (INLAND TRANSIT) CLAUSE

The liability of the insurer shall be limited to 75% of the assessed loss (or as Specified in the Schedule) where the consignment note is issued limiting the liability of the carriers in any respect by special contract duly signed by the consignor, consignee or by the duly authorized representative, agents or where the consignment note is issued by a private carrier (other than a vehicle belonging to the owner of goods) or freight broker. This warranty would not apply where loss or damage has occurred whilst the goods are not in the custody of the carriers.

PER SENDING LIMIT (PSL)/PER BOTTOM LIMIT

Notwithstanding anything to contrary contained in this contract the limit of the Company's liability in respect of any one accident or series of accidents arising from the same event shall not exceed the amount as specified in the schedule of the policy Shipment values exceeding this limit unless prior notice is given to the company suitable amendments have been made in the policy insured will be self-insurer and for partial losses condition of average will be applicable at time of claim.

LOCATION LIMIT/PER LOCATION LIMIT

Notwithstanding anything to the contrary stated herein, in the event of loss and/or damage to the subject matter insured or any expense incurred by way of sue and labour, the total liability of the company in any particular location, for all the insured consignments covered under this Policy in respect of any one accident/occurrence or a series of accidents and/or occurrences arising out of the same event, shall not exceed and shall be limited to the amount as mentioned in the Schedule.

This denotes accumulation of all shipments at any one place at any one time. If such accumulations do take place exceeding the location limit, unless prior notice is given to the company & suitable amendments have been made in the policy, condition of average will be applicable at time of claim.

CANCELLATION CLAUSE

This Policy may be cancelled by either the Company or the Assured giving 30 days notice in writing to take effect from the midnight of the date of notice but risks covered by Institute War Clauses may be cancelled at seven days notice (as per Paramount War Clause) and risks covered by the Institute Strikes Clauses/Strikes, Commotion Clause-Inland Transit may be cancelled at seven days notice, or at forty-eight hour notice in respect of shipments to or from the United States of America. Notice shall commence from midnight of the day when it is received but cancellation shall not apply to any risks which have attached in accordance with the cover granted hereunder before the cancellation becomes effective. The Company may terminate the contract on grounds of misrepresentation, fraud, non-disclosure or non-cooperation by the Assured by giving notice as mentioned in the above paragraph and there would be no refund of premium.

PARAMOUNT WAR CLAUSE

War risks in respect of cargo interests are covered as in the original policy subject to the limitations of the United Kingdom Waterborne Agreement dated 1.1.1982 and any subsequent amendment thereto. The cover against War risks (as defined in the relevant Institute War Clauses) may be cancelled by either the Underwriters or the Assured except in respect of any insurance which shall have attached in accordance with the conditions of the Institute War Clauses before the cancellation becomes effective. Such cancellation shall however only become effective on the expiry of 7 days from midnight of the day on which notice of the cancellation is issued by or to the Underwriters.

INSTITUTE REVISION CLAUSE

The Institute Clauses referred to herein are those current at the inception of this contract but should such clauses be revised during the period of this contract, and provided that the Company shall have given at least 30 days' notice thereof, then the revised Institute Clauses shall apply to risks attaching subsequent to the date of expiry of the said notice.

SUBROGATION CLAUSE

The Insured/Claimant under this Policy shall at the expense of the Company do and concur in doing, and permit to be done, all such acts and things as may be necessary or reasonably required by the Company for the purpose of enforcing any rights and remedies or of obtaining relief or indemnity from other parties (other than those insured under this Policy) to which the Company shall be or would become entitled or subrogated, upon its paying for or making good any loss or damage under this policy, whether such acts and things shall be or become necessary or required before or after his indemnification by the Company.

CONTRIBUTION CLAUSE

If at the time of any loss or damage happening to any property hereby insured there be any other subsisting insurance or insurances, whether effected by the Insured or by any other person or persons covering the same property, this Company shall not be liable to pay or contribute more than its rateable proportion of such loss or damage.

INSPECTION OF RECORDS CLAUSE

The Company or a person appointed by the Company may examine the books and records of the Assured as far as they relate to the subject matter of this insurance at any time during business hours while this insurance is in force and for twelve months after termination.

IMPORTANT NOTICE CLUASE

Procedure in the event of Loss or Damage for which Underwriters may be liable

Liability of Carriers, Bailees or other Third Parties

For Ocean Shipments

It is the duty of the Assured and their Agents, in all cases, to take such measures as may be reasonable for the purpose of averting or minimizing a loss and to ensure that all rights against Carriers, Bailees or other third parties are properly preserved and exercised. In particular, the Assured or their Agents are required:

- 1. To claim immediately on the Carriers, Port Authorities or other Bailees for any missing packages.
- 2. To apply immediately for survey by Carriers, or other Bailees' Representatives, if any loss or damage be apparent and claim on the Carriers or other Bailees for any actual loss or damage as found at such survey.
- 3. When delivery is made by container, to ensure that the container and its seals are examined immediately by their responsible official.

If the Container is delivered damaged or with seals broken or missing or with seals other than as stated in the shipping documents, to clause the delivery receipt accordingly and retain all defective or irregular seals for subsequent identification. 4. In no circumstances, except under written protest, to give clean receipts where goods are in doubtful condition.

- 5. To give notice in writing to the carriers or other Bailees within 3 days of delivery if the loss or damage was not apparent at the time of taking delivery.
- 6. To take examined delivery from the Carriers of packages which are outwardly damaged or appear to have been tampered with and obtain a Damage and/or Shortage Certificate from them. If any package appears to be deficient in weight, to take weightment/examined delivery from Carriers and an appropriate Certificates.
- 7. To issue Notices of claim against Carriers, Bailees or Third Parties by Registered Post with Acknowledgement Due Card

Note: The consignees or their Agents are recommended to make themselves familiar with the Regulations of the Port Authorities at the port of discharge.

Documentation of claims

To enable claims to be dealt with promptly, the Assured or their Agents advised to submit all available supporting documents without delay, including when applicable:

1. Original Policy or Certificate of Insurance.

- 2. Original or copy of Shipping invoices and Packing list and of Shipping Specification and / or weightment notes.
- 3. Original Bill of Lading and / or other contract of carriage.
- 4. Survey report or other documentary evidence (Damage/Non-Delivery Certificate) to show the extent of the loss or damage.
- 5. Landing Remarks and weightment notes, Remarks Lists at final destination.
- 6. Correspondence exchanged with the Carriers and other parties regarding their liability for the loss or damage along with copies of Notice of claim on the Carriers/Third parties and Receipted A/D Card/Postal Registration receipt.

INSTRUCTIONS FOR SURVEY

In the event of loss or damage which may involve a claim under this insurance, immediate notice of such loss or damage should be given to and a Survey Report obtained from the Company's representative at port of discharge or destination or if there be no representative of the Company, the nearest Lloyd's Agent.

For Inland Despatches

It is the duty of the Assured and their Agents in all cases to take such measures as may be reasonable for the purpose of averting or minimising a loss and to ensure that all rights against Carriers, Bailees or other Third parties are properly preserved and exercised. In particular, the Assured or their Agents/Consignees must:

- 1. under no circumstances, given clean receipts to the Carriers in respect of packages which are offered to them for delivery in a doubtful condition, except under written protest.
- 2. take examined delivery from the Carriers of any packages which are outwardly damaged or appear to have been tampered with and obtain a Certificate of Damage and/or Shortage from the Carriers, if the Carriers should refuse to grant examined delivery, suitable remarks as to the condition of the packages and the contents thereof should be made in the Railway Station Delivery Book or on the negotiable copy of the Consignment Note in the case of despatches by Road/Aircraft.
- 3. take weighment/examined delivery of any packages which are in an outwardly sound condition, but deficient in weight, as compared with the booked weight, and obtain a Certificate of Shortage from Carriers, if deficiency in weight is proved.
- 4. issue notice of claim against the Carriers by Registered Post A/D.

Note: The Company's liability shall succeed and not in any way supersede that of the Carriers, Bailees or other third parties concerned.

Documentation of claims

To enable claims to be dealt with promptly, the Assured and their Agents advised to submit all available supporting documents without delay, including when applicable:

- 1. Original policy or Certificate of Insurance.
- 2. Originals or copies of the Supply Invoice and Packing / Weight specifications.
- 3. The negotiable or other copy of the Carriers' Receipt and/or the original of the Carriers' Certificate of non-delivery or Certificate of Damage and / or Shortage.
- 4. Survey Report or other documentary evidence of the loss or damage.
- 5. Copies of Notices of Claim against the Carriers and other Third Parties together with the relative Postal Registration Receipts and receipted A/D Cards and copies of all subsequent correspondence exchanged with them.
- 6. Claim Bill.

In the event of loss of or damage to the interest insured whilst in the custody of the Carriers, a proper notice of claim, specifying details of the consignment, full booking particulars, the nature and extent of loss / damage and the amount of compensation, with COPIES of the relative Supply Invoice and the Carrier's Certificate of Nondelivery or Certificate of Damage and/or Shortage, must be issued against.

a. The General Managers or Chief Commercial Superintendents of the Railway Administrations on which the booking and destination stations lie within 6 months from the date of booking in terms of section 106 of the Indian Railways (Amendment) Act, 1989 (Subject to amendments to the Indian Railway Act); or

b. The Owners of the Inland Vessels or the Road Carries concerned (booking and destination offices) within 6 months from the date of booking in terms of Section 10 of the Carriers' Act 1865; or

c. The Air Carriers concerned, within 7 days from the date of delivery of the goods at destination or, in the case of Nondelivery, within 14 days from the date of booking, in terms of Rule 26(2) chapter III of the Indian Carriage by Air Act; or d. The Postal Authorities concerned within 6 months from the date of booking.

Notice of claim as above should be served by the actual owners of the goods (consignors of consignees as the case may be) such notice should specify that they are also being served on behalf of the Insurers.

The Postal Registration Receipts and receipted A/D Cards relative to such notices of claim, also any official acknowledgements / replies from the Carriers should be carefully preserved.

The originals of the Carriers' Receipt or Certificate of Non-delivery or Certificate of Damage and/or shortage must not be surrendered to the Carriers without prior reference to the Company.

CLAIM NOTIFICATION PROCEDURE

In the event of loss or damage which may involve a claim under this insurance policy, notification should be given to insurers in reasonable time from date of delivery of consignment.

ARBITRATION

If the claim be in any respect fraudulent, or if any false declaration be made or used in support thereof or if any fraudulent means or devices are used by the Insured or any one acting on his behalf to obtain any benefit under the policy or if the loss or damage be occasioned by the willful act, or with the connivance of the Insured, all benefits under this policy shall be forfeited. If a claim is made and rejected and no action or suit is commenced within three months after such rejection or in case of Arbitration taking place as provided herein within three months after the Arbitrators or Umpire have made their award, all benefit under this Policy shall be forfeited.
