Subject: Show Cause Notice

In reference to your appointment dated 24<sup>th</sup> March, 2015 as an Insurance Agent of MAGMA HDI General Insurance Company Limited (hereinafter referred as "the Company") post successful completion of required training in terms of IRDAI's Guidelines Appointment of Insurance Agent, 2015 [erstwhile IRDA (Licensing of Insurance Agents) Regulations, 2000, as amended from time to time and collectively referred as "the Insurance Agency Guidelines"].

In this regard, the Company would specifically like to draw your attention that in terms of the Code of Conduct prescribed under the relevant Insurance Agency Guidelines is binding upon you to adhere to it at all times as an insurance agent of the Company.

It has come to the knowledge of the Company during an enquiry conducted by the officials of the Company that premium amount for the below mentioned policy is pending with you:

Thus, clarification is required in the said matter providing the reasons for delay in depositing the amount. This act of yours has resulted in breach of code of conduct prescribed in the Guidelines.

In view of the above, we hereby issue this Show Cause notice and call upon you to submit your explanation to this show cause notice as to why suitable action including but not limited to termination, civil and criminal proceedings should not be initiated against you for the aforementioned act of breach of trust and other acts committed by you, within 21 days from the date of receipt of this notice.

In case the Company does not receive any response / clarification within the stipulated timeline, it would be deemed that you have nothing to submit in your defense and unconditionally accepts the allegation made against you.
