**Subject: Show Cause Notice** 

In reference to your appointment dated 2<sup>rd</sup> November, 2016 as an Insurance Agent of MAGMA HDI General Insurance Company Limited (hereinafter referred as "the Company") post successful completion of required training and examination in terms of IRDAI's Guidelines on Appointment of Insurance Agent, 2015 [erstwhile IRDA (Licensing of Insurance Agents) Regulations, 2000, as amended from time to time and collectively referred as "the Insurance Agency Guidelines"].

In this regard, The Company would specifically like to draw your attention that in terms of the Code of Conduct prescribed under the relevant Insurance Agency Regulation is binding upon you to adhere to it at all times as an insurance agent of the company.

That during an enquiry conducted by the officials of the Company it has come to the knowledge that a policy no. P0017200009/4101/100447 was issued through you for the period of 31.01.2017 to 30.01.2017 in the name of Mr. Lal Bihari Barik on the basis of forged and fabricated declaration provided by you on behalf of insured towards non-claiming of any pre-existing damages. However, subsequently after issuance of policy a claim was intimated to us for damages which were pre-existing for the vehicle insured under the said policy and insured has denied issuing any such declaration.

This fraudulent act of yours has resulted in breach of code of conduct prescribed in the Insurance Agency Guidelines.

In case the Company does not receive any response / clarification, it would deem that you have nothing to submit in your defense and unconditionally accepts the allegation made against you.
